**1. APOLOGIES:** None.

**2. ADOPTION OF PREVIOUS MINUTES:** Proposed by A Guthrie, Seconded Mr J Eaglesham.

### **3. MATTERS ARISING:**

**PUMPING STATION, SEAVIEW:** Members of the public including Mr Guthrie and Mr Storie attended the Planning meeting on 8 November. The Planning Committee are holding over their decision until they have a site visit, as there were numerous objections to the siting of this. Dawn McDermott, Scottish Water, is intending to visit the site at this time. The Harbour committee has no objections to a gravity system round the harbour if this is feasible. A suggestion was made to have an independent Civil Engineer look at this project, however, funding would have to be sought to pay for this. Scottish Water still intends to proceed with construction early in the New Year, starting at the main site until the above matter is resolved.

**BENCH:** Councillor Murray has passed on price list and Gillian Anderson will investigate possibilities of funding for this.

**BONFIRE NIGHT:** Mr Eaglesham thanked Community Council for donation towards bonfire night, which was a great success. Thanks due to Phil Findlay for supplying wood for the bonfire.

**TOILETS:** A Guthrie now has list of toilet opening times in South Ayrshire and we now discover Dunure is one of the few villages with no toilet facilities during the winter months. It was understood why toilets remain open A77 route, but other villages off this route have winter facilities. Councillor Murray will look into this.

**4. POLICE REPORT:** P C John Hamil is pleased to report there have no crimes reported since last meeting.

**5. COUNCILLOR'S REPORT:** Councillor Murray had made enquiries about a bench but no money available in the current year. Price list however available - £280 upwards for bench plus delivery and installation charges.

No reply about paths between Kennedy Drive and Carrick Place.

Green skateboard could be repainted but the Community Council thought this was unnecessary, and the colour would probably tone down as it weathered.

Speed Bumps: No money available at the moment but South Ayrshire Council are looking at their policy on speed bumps for the whole council area.

Energy Efficiency: Councillor Murray will try and arrange for an energy efficiency officer to come to a meeting.
