

## **DUNURE COMMUNITY COUNCIL**

Minutes of a Meeting held on Tuesday 15th August 2006 in the Kennedy Hall.

**1. APOLOGIES:** Mr A Guthrie.

**2. ADOPTION OF PREVIOUS MINUTES (20th June 2006) :** Proposed by Mr D Broadhead, Seconded by Mr P Findlay.

**3. POLICE REPORT:** P C John Hamil reports only incident during last two months was theft of golf clubs. Outboard motor which had previously been stolen had turned up. This was identified through serial number. Suggests everyone be on the alert as there have been opportunist crimes in the surrounding areas, also beggars asking for money.

### **4. MATTERS ARISING:**

**WASTE WATER TREATMENT WORKS:** As the council is in recess until the end of August there has been no site visit at Seaview as yet.

**LARGE SKIP:** As this has been left to Mr Guthrie to co-ordinate, we will await his comments at next meeting.

**WINDFARM:** A letter was sent to Neil Feggans, South Ayrshire Council, supporting this project.

**OPEN FORUM:** No members of the community attended, and on the subject of co-option it was suggested a younger member of the community might be interested. Secretary will check with the handbook for rules.

**5. COUNCILLOR'S REPORT:** Councillor Murray spoke re the article in local press about the restructuring of South Ayrshire Schools and confirms this has not been investigated as yet, but that the Council is proposing to look into the possibilities. He also suggested he contacts Gillian Anderson who is drafting a "Community

Newsletter" for Maidens, and perhaps the same could be done for Dunure. John Eaglesham volunteered the Youth Club to distribute this Newsletter if we get it up and running. It was thought perhaps two per year could be issued to the local community.
