1. **Adoption of minutes for meeting of Tuesday 17 June 2008.**

2. POLICE REPORT:

June - July: During the month there have been only two reported crimes to the Police, the first being the theft of a trailer and the second when two males were reported for disorder offences.

July - August: During the month there has been only one reported crime to the Police when one male was reported for a traffic offence.

3. COUNCILLOR'S REPORT:

The ongoing problem of the bus turning area was discussed and the Councillor was asked when it was likely to have some sort of restrictions on parking (ie lines or crosshatching) to enable the buses to turn in this area with safety.

Mr Storie advised the graffiti had still not been removed from the castle.

Mr Findlay asked about the legality of banners on Fort Street at the junction of Cathcart Street which had been attached to the railings adjacent to the pedestrian crossing.

The problem of the ditch on the east side of Station road opposite the Waste Water Treatment Works was again discussed and it was agreed that South Ayrshire Council should consider some permanent solution to this perhaps by inserting a drainage pipe.

The Community Council still feel that some speed restrictions should be put in place on Station Road. Either speed bumps, continuation of the 30mph limit or some other measure to slow down traffic.

4. MATTERS ARISING:

- i. **PUMPING STATION AT SEAVIEW:** The majority of the Community Council are quite happy with the completed work. Secretary will contact Scottish Water Solutions for information on the date this system will be in operation. Also what the plans are to complete the entrance on Station Road to the main works. There have been camper vans and tents using this area overnight. The area where the bench is to be positioned will also need to be tidied and this should be the responsibility of the contractor, GMJV.
- ii. **It was agreed** a voucher should be purchased for Mr McCrindle for his kindness in taking Mr Storie out in his boat to photograph the coastline.
- iii. **LABYRINTH:** As Mr Guthrie was absent, we will await a report next month.
- iv. **CIVIC PRIDE:** Bench has been delivered and paid for. Enviroscope has been delivered and paid for. We are hoping Owen Kerr Signs will erect the "speed bumps" signs in the

park soon so that this can be paid. All then that will be left to pay is the cost of the hard landscaping in the area where the bench will go.
